Smelters and refineries that are not certified by RMI or do not meet the relevant requirements must be removed from the supply chain and subject to due diligence as required by the Organization for Economic Co-operation and Development (OECD).

5.1

Supplier conflict minerals survey:

5.1.1

According to the actual product demands, R&D department will release the required material specifications and other related requirements to the procurement department, and ask the procurement department to source the appropriate suppliers for sample approval. The

5.1.2

SQA RMI\_CMRT

The procurement department selects appropriate suppliers according to the specifications and quality requirements of the R&D department for the materials and requires suppliers to send samples for confirmation. Meanwhile, SQA releases the RMI\_CMRT questionnaire and the Social Responsibility Agreement to be signed by all subcontractors and suppliers and execute the conflict minerals survey of the materials.

The Smelters shall undergo recertify to obtain permission, and get in touch with customers to determine whether to continue delivery during the process.
